An interactive map on your web site would do the trick - this will show up the post code lottery the CCGs are presiding over in terms of care closer to home provision by GP network over the whole STP area.

- B) Please, if possible define what the care closer to home end point looks like by GP network. People want to know what to expaect and what they are getting for their hard earned cash investment in the local NHS.
- C) Please agree what can be delivered over the next 1, 2, and 3 years and advise the public accordingly.
